Woman-owned Business – Certification by the Women's Business Enterprise National Council (WBENC) is required. You may find more information regarding certification by visiting their website at http://wbenc.org. Should your company be asked to participate in a bidding opportunity, we will ask you to verify your status at that time.

Veteran – owned Small Business or Service-Disabled-Veteran-owned Small Business – Register your company in the Central Contractor Registration (CCR) at their web site (http://www.ccr.gov) Should your company be asked to participate in a bidding opportunity, we will ask you to verify your status at that time.

Small Disadvantaged Business (SDB) – A company that is certified by the Small Business Administration (SBA) as a Small Disadvantaged Business (SDB) should already be registered in the Central Contractor Registration (CCR) at their Web site. In addition, should your company be asked to participate in a bidding opportunity, we will require a paper copy of the letter from the Small Business Administration certifying your company as a Small Disadvantaged Business.

HUBZone Small Business – A company that is certified by the Small Business Administration (SBA) as a HUBZone Small Business should already be registered in the Central Contractor Registration (CCR) at their Web site. In addition, should your company be asked to participate in a bidding opportunity, we will require a paper copy of the letter from the Small Business Administration approving your company as a HUBZone Small Business.
